**SECTION 4 : FIRST AID MEASURES**

As a general rule, in case of doubt or if symptoms persist, always call a doctor.

NEVER induce swallowing by an unconscious person.

**4.1. Description of first aid measures**

**In the event of exposure by inhalation :**

If inhaled, move the patient to fresh air and keep warm and at rest

**In the event of splashes or contact with eyes :**

Wash thoroughly with soft, clean water for 15 minutes holding the eyelids open.

If there is any redness, pain or visual impairment, consult an ophthalmologist.

**In the event of splashes or contact with skin :**

Remove contaminated clothing and wash the skin thoroughly with soap and water or a recognised cleaner.

Watch out for any remaining product between skin and clothing, watches, shoes, etc.

In the event of an allergic reaction, seek medical attention.

If the contaminated area is widespread and/or there is damage to the skin, a doctor must be consulted or the patient transferred to hospital.

**In the event of swallowing :**

Do not give the patient anything orally.

In the event of swallowing, if the quantity is small (no more than one mouthful), rinse the mouth with water and consult a doctor.

Keep the person exposed at rest. Do not force vomiting.

Seek medical attention immediately, showing the label.

If swallowed accidentally, call a doctor to ascertain whether observation and hospital care will be necessary. Show the label.

**SECTION 5 : FIREFIGHTING MEASURES**

Flammable.

Chemical powders, carbon dioxide and other extinguishing gas are suitable for small fires.

**5.1. Extinguishing media**

**Suitable methods of extinction**

**SECTION 6 : ACCIDENTAL RELEASE MEASURES**

**6.1. Personal precautions, protective equipment and emergency procedures**

- Consult the safety measures listed under headings 7 and 8.
- Prevent every risk of ignition of the steams.
- Prevent the risks caused by the inhalation of steams.

**For non first aid worker**

- Because of the organic solvents contained in the mixture, eliminate sources of ignition and ventilate the area.
- Avoid any contact with the skin and eyes.

**For first aid worker**

- First aid workers will be equipped with suitable personal protective equipment (See section 8).

**6.2. Environmental precautions**

- Contain and control the leaks or spills with non-combustible absorbent materials such as sand, earth, vermiculite, diatomaceous earth in drums for waste disposal.
- Prevent any material from entering drains or waterways.

- If the ground is contaminated, once the product has been recovered by sponging with an inert and non-combustible absorbent material, wash the contaminated area in plenty of water.

**SECTION 7 : HANDLING AND STORAGE**

- Requirements relating to storage premises apply to all facilities where the mixture is handled.
- Individuals with a history of skin sensitisation should not, under any circumstance, handle this mixture.

**7.1. Precautions for safe handling**

- Always wash hands after handling.
- Remove and wash contaminated clothing before re-using.
- Ensure that there is adequate ventilation, especially in confined areas.
- Remove contaminated clothing and protective equipment before entering eating areas.
- Do not eat or drink during the use.
- Follow hygiene and security rules because flammable capacity.
- Prevent every contact with the skin and the eyes.
- Use away of every flame or incandescent point.

**Fire prevention :**

- Handle in well-ventilated areas.
- Vapours are heavier than air. They can spread along the ground and form mixtures that are explosive with air.
- Prevent the formation of flammable or explosive concentrations in air and avoid vapor concentrations higher than the occupational exposure limits.
- Prevent the accumulation of electrostatic charges with connections to earth.
- The mixture can become electrostatically charged : always earth during decanting operations. Wear antistatic shoes and clothing and floors should be electrically conductive.
- Use the mixture in premises free of naked flames or other sources of ignition and ensure that electrical equipment is suitably protected.
- Keep packages tightly closed and away from sources of heat, sparks and naked flames.
- Do not use tools which may produce sparks. Do not smoke.
- Prevent access by unauthorised personnel.

**Recommended equipment and procedures :**

- For personal protection, see section 8.
- Observe precautions stated on label and also industrial safety regulations.
- Avoid skin and eye contact with this mixture.
- Packages which have been opened must be reclosed carefully and stored in an upright position.
- Follow the hygiene and security rules.
- Use only in well-ventilated premises.

**Prohibited equipment and procedures :**

- No smoking, eating or drinking in areas where the mixture is used.
- Never open the packages under pressure.

**8.2. Exposure controls**

**Personal protection measures, such as personal protective equipment**

- Use personal protective equipment that is clean and has been properly maintained.

**- Hand protection**
