SECTION 4 : FIRST AID MEASURES

SECTION 5 : FIREFIGHTING MEASURES

Flammable.

Chemical powders, carbon dioxide and other extinguishing gas are suitable for small fires.

5.1. Extinguishing media

Keep packages near the fire cool, to prevent pressurised containers from bursting.

Suitable methods of extinction

In the event of a fire, use :

- sprayed water or water mist
- water with AFFF (Aqueous Film Forming Foam) additive
- halon
- foam
- multipurpose ABC powder
- BC powder
- carbon dioxide (CO₂)

5.3. Advice for firefighters

Due to the toxicity of the gas emitted on thermal decomposition of the products, fire-fighting personnel are to be equipped with autonomous insulating breathing apparatus.

6.1. Personal precautions, protective equipment and emergency procedures

For non first aid worker

Because of the organic solvents contained in the mixture, eliminate sources of ignition and ventilate the area.

Contain and control the leaks or spills with non-combustible absorbent materials such as sand, earth, vermiculite, diatomaceous earth in drums for waste disposal.

Prevent any material from entering drains or waterways.

Clean preferably with a detergent, do not use solvents.

The elimination must be carried out by a registered salvage professional.

SECTION 7 : HANDLING AND STORAGE

Requirements relating to storage premises apply to all facilities where the mixture is handled.

7.1. Precautions for safe handling

- Always wash hands after handling.
- Remove and wash contaminated clothing before re-using.
- Ensure that there is adequate ventilation, especially in confined areas.

Fire prevention :

- Handle in well-ventilated areas.
- Vapours are heavier than air. They can spread along the ground and form mixtures that are explosive with air.
- Prevent the formation of flammable or explosive concentrations in air and avoid vapor concentrations higher than the occupational exposure limits.
- Prevent the accumulation of electrostatic charges with connections to earth.
- The mixture can become electrostatically charged : always earth during decanting operations. Wear antistatic shoes and clothing and floors should be electrically conductive.
- Use the mixture in premises free of naked flames or other sources of ignition and ensure that electrical equipment is suitably protected.
- Keep packages tightly closed and away from sources of heat, sparks and naked flames.
- Do not use tools which may produce sparks. Do not smoke.
- Prevent access by unauthorised personnel.

Recommended equipment and procedures :

- For personal protection, see section 8.
- Observe precautions stated on label and also industrial safety regulations.
- Where the personnel must carry out work in a booth, whether for spraying or otherwise, the ventilation may be inadequate to control particles and solvent vapors in every case.
- It is therefore recommended that personnel wear masks with a compressed air supply during spraying operations until the concentration of particles and solvent vapors has fallen below the exposure limits.
- Avoid eye contact with this mixture.
- Packages which have been opened must be reclosed carefully and stored in an upright position.

Prohibited equipment and procedures :

- No smoking, eating or drinking in areas where the mixture is used.

7.2. Conditions for safe storage, including any incompatibilities

8.2. Exposure controls

Personal protection measures, such as personal protective equipment

Use personal protective equipment that is clean and has been properly maintained.

Store personal protective equipment in a clean place, away from the work area.

Never eat, drink or smoke during use. Remove and wash contaminated clothing before re-using. Ensure that there is adequate ventilation, especially in confined areas.

- Eye / face protection

Avoid contact with eyes.

Use eye protectors designed to protect against liquid splashes

Before handling, wear safety goggles with protective sides accordance with standard EN166.

In the event of high danger, protect the face with a face shield.

When spraying, wear a face shield in accordance with standard EN166.

Prescription glasses are not considered as protection.

Individuals wearing contact lenses should wear prescription glasses during work where they may be exposed to irritant vapours.

Provide eyewash stations in facilities where the product is handled constantly.
